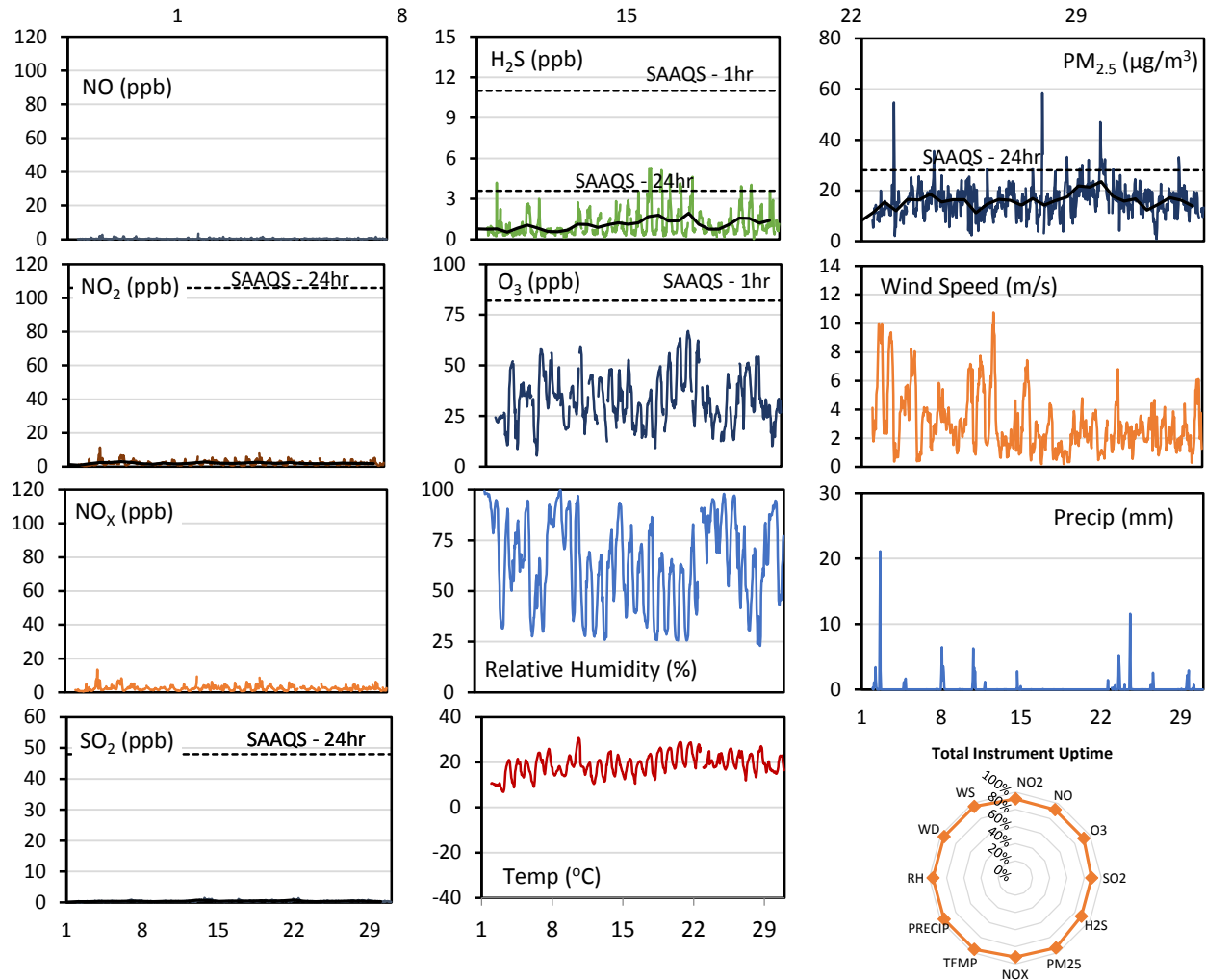
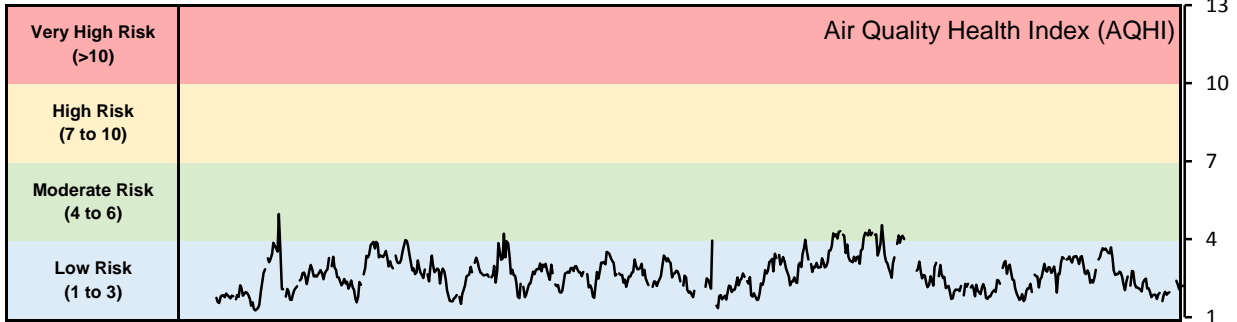
Monthly Update

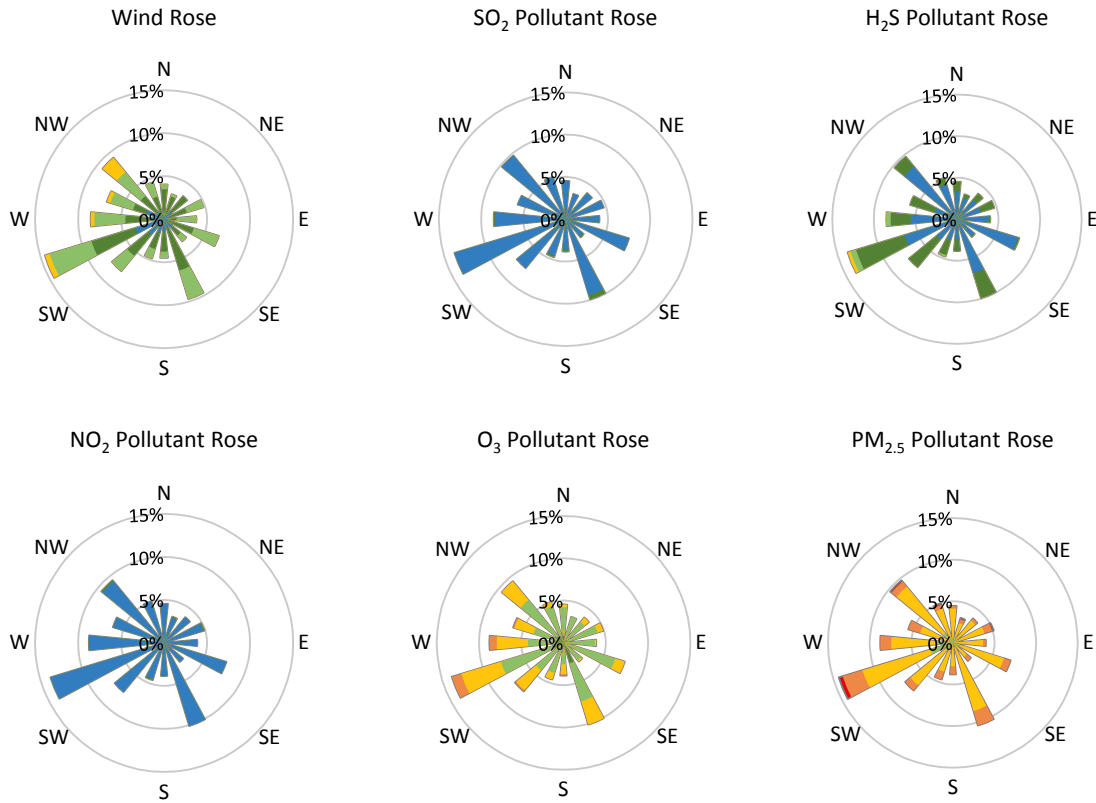
